The 2011 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to mill and resurface roadway pavement in the vicinity of the Operations Building. The project also includes drainage improvements at two (2) locations adjacent to the Fire Training Center facility.

The objective of this contract is to replace substandard areas of asphalt paving, thus addressing the County Executive's priority area: Safety and Security (SS).

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that roadways at Valhalla Campus meet current codes and standards as well as reducing the County's annual maintenance costs.

The project will provide an environmental benefit by eliminating erosion due to flooding.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further
