The objective of this contract is to replace substandard areas of asphalt paving and concrete sidewalks, thus addressing the County Executive's priority area: Safety and Security (SS).

This contract is in the Public's best interest because it will promote the health and safety of the general public by ensuring that County roadways and sidewalks meet current codes and standards as well as reducing the County's annual maintenance costs. There are no environmental or energy components in this project.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
