Re: Authority to enter into an agreement with the New York State Department of Motor Vehicles (“DMV”), pursuant to which DMV will provide the County with certain data for the purpose of assisting the County in identifying individuals who are fraudulently obtaining County-provided services and/or benefits, for a term commencing upon execution and continuing indefinitely until it is terminated by DMV, at no cost to the County

Authority is respectfully requested for the County of Westchester (the “County”) to enter into an agreement with the New York State Department of Motor Vehicles (“DMV”), pursuant to which DMV will provide the County with name, date of birth, Social Security number, gender, and address data for the purpose of assisting the County in identifying individuals who are fraudulently obtaining County-provided services and/or benefits, for a term commencing upon execution and continuing indefinitely until it is terminated by DMV, at no cost to the County.

The proposed agreement will serve a public purpose by providing the County with data that it will be able to use in order to identify individuals who are fraudulently obtaining County-provided services and/or benefits, and thereby assist the County in more effectively and efficiently administering benefit programs serving the population of Westchester County.

The goal and objective of the proposed agreement is to obtain from DMV data that will assist the County in identifying individuals who are fraudulently obtaining County-provided services and/or benefits.

The goal and objective of the proposed agreement is in the best interests of the County in terms of fiscal responsibility, as the identification of individuals who are fraudulently obtaining County-provided services and/or benefits, and the related increases in the effectiveness and efficiency of the County's administration of those services and/or benefits, will reduce the costs of those services and/or benefits.

The goal and objective of the proposed agreement will be tracked and monitored by the Department of Social Services.

This procurement is exempt from the requirements of the County Procurement Policy pursuant to Section 3(a)(iii) thereof.

I most respectfully recommend and urge the adoption of the annexed Resolution.
