On April 27, 2011, eight (08) bids were received and opened for Contract No. 10-531 for Installation of New Water Service, Tibbetts Brook Park, Yonkers, New York.

The bids were reviewed by the Department and it was determined that Joken Development Corp. submitted the low bid in the amount of \$891,990.00.

The low bidder has been investigated and it has been found that Joken Development Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace the existing undersized water main serving the bathhouse and the water park.

This contract is in the public's best interest because it will promote the health and safety of the general public by providing the required volume of water to operate the bathhouse and the water park, thus addressing the County Executive's priority area: Health and the Environment (HE). There are no energy or environmental components associated with this project.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 10-531 be awarded to Joken Development Corp., in the amount of \$891,990.00.
