Attached for your consideration is a Resolution which, if approved by your Honorable Board, would authorize the Department of Public Works and Transportation to solicit bids by public advertisement for the above referenced project.

The work under this contract will consist of all necessary labor, materials and equipment for snow removal from parking lots, selected roadways and apron areas at the Westchester County Airport for a period of three (3) years commencing October 1, 2011 and ending September 30, 2014.

This contract will benefit the public by providing safe roadways and parking lots for travelers during the winter season through plowing and ice control. The goals and objectives of this contract are to promptly remove snow and ice from traveled areas of the Airport.

Airport Operations will oversee the contract and monitor performance by the contractor. Payment will only be made to the contractor upon satisfactory completion of a snow removal event and all roadways and parking areas are passable and in a safe condition for travelers.

Payment for this contract will be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.

A proposed resolution to authorize the bid advertisement is attached for your consideration.

RESOLUTION

Upon communication from the Commissioner of Public Works and Transportation, be it

RESOLVED, that the Commissioner of Public Works and Transportation be and he hereby is authorized to solicit bids by public advertisement on the following contract:

and be it further

RESOLVED, that this service contract will be for a period of three (3) years commencing October 1, 2011 and ending September 30, 2014; and be it further

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance and payment bond in an amount equal to 30% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the US Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women – Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
