The 2011 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required for replacement of sidewalks and bridge railings, removal of high density concrete overlay and repair of bridge deck. Work also includes installation of membrane waterproofing, asphalt wearing surface and joints along with painting and repair of structural steel and the repair of substructures.

The objective of this contract is to repair substandard structural elements of the North Street Bridge, thus addressing the County Executive's priority area: Safety and Security (SS).

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the North Street Bridge meets current codes and standards as well as reducing the County's annual maintenance costs. There are no energy or environmental components associated with this project.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
