SUBJECT: Authority to enter an agreement with the Substance Abuse and Mental Health Services Administration (“SAMHSA”), a division of the U.S. Department of Health and Human Services to fund the Westchester Coalition for Drug and Alcohol Free Youth’s underage drinking and drug use prevention programs for the period September 30, 2011 through September 29, 2016 for an amount not to exceed \$625,000.00

Authority is sought for the County of Westchester (the “County”) to enter into a grant agreement with Substance Abuse and Mental Health Services Administration (“SAMHSA”), a division of the U.S. Department of Health and Human Services in the amount not to exceed \$125,000.00 per year for a period of five years for an aggregate amount not to exceed \$625,000.00, pursuant to which the Office of STOP DWI will fund the Westchester Coalition for Drug and Alcohol Free Youth’s work with communities to combat underage drinking and other drug use and to promote healthy behaviors among the youth in the County.

The grant funds will enable the Department of Public Safety’s STOP DWI Program to strengthen the Westchester Coalition’s efforts to prevent and reduce youth substance abuse and enhance collaboration among all sectors. No County funds are required for this program.

Accordingly, I most respectfully recommend your Board’s favorable consideration of the annexed proposed Resolution

RESOLUTION

Upon a communication from the Commissioner-Sheriff of Public Safety, be it hereby

RESOLVED, that the County of Westchester, acting by and through its Department of Public Safety, is authorized to enter a grant agreement with the Substance Abuse and Mental Health Services Administration (“SAMHSA”), a division of the U.S. Department of Health and Human Services to fund the Westchester Coalition for Drug and Alcohol Free Youth’s programs combating underage drinking and other drug use and promoting healthy behavior among the youth of Westchester County for the period September 30, 2011 through September 29, 2016 in the amount not to exceed \$125,000.00 per year for a period of five years for a total aggregate amount not to exceed \$625,000.00, to be paid in accordance with an approved budget; and be it further

RESOLVED, that this Agreement is subject to County appropriations; and be it further

RESOLVED, that the County Executive or his authorized designee is authorized and empowered to execute and deliver all instruments and take all action necessary and appropriate to effectuate the purpose hereof.
