SUBJECT: Resolution authorizing an agreement between the County of Westchester and the Suburban Green Housing Development Fund Corp. to subsidize the purchase price of the property located at 4 Morris Place in the City of Yonkers

The attached resolution authorizes the County of Westchester to enter into an agreement with the Suburban Green Housing Development Fund Corp. to receive grant funds through the New York State Affordable Housing Corporation's Affordable Homeownership Development Program. The grant will be used to subsidize the purchase price of the two-family home located at 4 Morris Place in the City of Yonkers. The term of the agreement will be November 7, 2011 to November 6, 2012, and the grant amount is \$40,000.00, pursuant to an approved budget.

Suburban Green Housing Development Fund Corp. provides financial, technical and educational resources to affordable housing and community and economic development initiatives through a variety of programs including affordable housing lending and support for micro-businesses including grants, loans and technical assistance.

This procurement exempt from the requirements of the County Procurement Policy and Procedures pursuant to Section 3(a) xii, thereof, which exempts procurements which involve the expenditure of federal or state assistance where and to the extent that federal or state law, rules or regulation conflict with the provisions of this policy. The County submitted an application to the New York State Affordable Housing Corporation (NYSAHC) for this grant and was awarded these funds in order to provide the funds to the eligible developers to underwrite the cost of rehabilitation on behalf of income eligible homebuyers. This specific grant from New York State Affordable Housing Corporation's Affordable Homeownership Development Program requires that the funds can only be used on the Neighborhood Stabilization Properties (NSP). This agency has received an NSP grant in the amount of \$520,000 to acquire and rehabilitate this property, and pursuant to the NYSAHC grant award, NYSAHC approved Suburban Green Housing Development Corp as the developer to receive funds for this project.

The goal and objective of this agreement is to provide affordable housing to low income families in Westchester County. Department of Planning staff will monitor ongoing occupancies to ensure the units are primary residences, review all re-sales or refinances of the property and provide approvals for subsequent income eligible tenant households to assure the units are maintained as affordable housing for the term of affordability.

On February 19, 2009, the Board of Acquisition and Contract approved a resolution authorizing the County of Westchester to enter into an agreement with the State of New York Housing Finance Agency for a grant totaling \$6,680,000.00 and a grant of \$640,000.00 from the Affordable Housing Corp. for a total amount of \$7,320,000.00.

I recommend approval of this agreement.
