The Contract was subsequently executed.

Contract completion was delayed due to field conditions and construction issues. Therefore, the County now seeks authority from your Honorable Board to amend the September 10, 2010 Resolution budget box end date from March 22, 2012 to June 30, 2013.

All other terms and conditions of the September 10, 2010 Resolution and the Contract shall remain in full force and effect and unchanged.
