By Resolution approved on December 30, 2010 your Honorable Board awarded Contract No. 09-553 for Active Recreation Improvements, Sprain Ridge Park and Tibbetts Brook Park, City of Yonkers, New York to Pat Corsetti, Inc. in the amount of \$803,174.50, for the period January 13, 2011 through April 12, 2012. The Contract was subsequently executed.

Contract completion was delayed due to field conditions and construction issues. Therefore, the County now seeks authority from your Honorable Board to amend the December 30, 2010 Resolution budget box end date from April 12, 2012 to October 31, 2012.

All other terms and conditions of the December 30, 2010 Resolution and the Contract shall remain in full force and effect and unchanged.
