The 2012 Operating Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to provide snow and ice removal services for all parking lots and pedestrian areas for the following locations: 750 Washington Street, Peekskill; 25 Moore Avenue, Mount Kisco; and Hilltop Hanover Farm, 1271 Hanover Street, Yorktown Heights. This contract is for a term of three (3) years with one two (2) year renewal at the discretion of the County.

The objective of this contract is to clear snow and ice from parking lots and pedestrian areas at various County facilities.

This contract is in the public's best interest because it will promote the health and safety of the general public by providing safe travel ways for both pedestrian and vehicular traffic at County facilities, thus addressing the County Executive's priority area: Safety and Security (SS). There are no environmental or energy components associated with this project.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be retainage of 10% of all work completed on an annual basis. Upon each annual anniversary the contractor may request payment of said retainage with the successful completion of all work performed during that period; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
