On June 6, 2012, three (03) bids were received and opened for Contract No. 12-518 for Exterior Repairs – Phase II, Michaelian Office Building, White Plains, New York.

The bids were reviewed by the Department and it was determined that Caladri Development Corp. submitted the low bid in the amount of \$1,249,110.00.

The low bidder has been investigated and it has been found that Caladri Development Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to repair structural elements and to maintain the weather tightness of the existing structure, thus addressing the County Executive's priority area: Safety and Security (SS).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
