On July 11, 2012, ten (10) bids were received and opened for Contract No. 11-536 to Repave Hangar 6 Public Aircraft Apron and Install Blast Fence, Westchester County Airport, Towns of Harrison and North Castle and Village of Rye Brook, New York.

The bids were reviewed by the Department and it was determined that ELQ Industries, Inc. submitted the low bid in the amount of \$1,157,615.00.

The low bidder has been investigated and it has been found that ELQ Industries, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

Funds for this project are available in the:

- Capital Budget
 Non-Recurring Budget
 Operating Budget

The objective of this contract is to replace substandard areas of asphalt paving and to improve the blast fencing system.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Airport meets FAA standards, thus addressing the County Executive's priority area: Safety and Security (SS).

The project will provide an environmental benefit by eliminating flooding and erosion.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

Payment for this entire contract will be made from Federal Aviation Administration Funds and the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.

It is my recommendation that Contract No. 11-536 be awarded to ELQ Industries, Inc. in the amount of \$1,157,615.00.
