RE: **Resolution authorizing the County of Westchester, acting through its Department of Public Safety, to accept the Pipes and Drums of the Police Emerald Society of Westchester County, Inc.'s exercise of its option for the use of a portion of the Westchester County Police Academy for periodic practice sessions**

On or about September 14, 2007, Your Honorable Board authorized the County of Westchester, acting through its Department of Public Safety, to enter into an Agreement with the Pipes and Drums of the Police Emerald Society of Westchester, Inc. (the "Emerald Society") for the use of a portion of the Westchester County Police Academy for periodic practice sessions. The license would commence October 1, 2007, and would have a term of five (5) years, with the option (at the Emerald Society's discretion) of a single five (5) year renewal.

The Emerald Society has indicated that it would like to exercise that option and the County would like to accept the same. Thus, authority is hereby requested in order to authorize the County to accept the Emerald Society's exercise of its option for the use of a portion of the Westchester County Police Academy for periodic practice sessions for the five (5) year option period October 1, 2012 through September 31, 2017. All other terms and conditions of the original agreement shall remain unchanged.

This will serve a public purpose by providing the Emerald Society access to needed practice space which facilitates the services provided to the Department of Public Safety at events such as Police Memorial Day and funerals for deceased sworn members.

Accordingly, your favorable action on this annexed Resolution is most respectfully urged and recommended.

RESOLVED, that the term of the option period shall commence October 1 2012, for a five (5) year option period; and be it further

RESOLVED, that all other terms of the original agreement shall remain unchanged; and be it further

RESOLVED, that the County Executive or his duly authorized designee is authorized and empowered to execute and deliver all instruments and take all actions necessary or appropriate to effectuate the purposes hereof.
