amount of \$160,000, payable pursuant to an approved budget

The Westchester County Department of Health (the "WCDH") seeks authorization to enter into contract with Children's Health and Research Foundation ("CHRF") to continue and refine a multi media outreach campaign which targets women of childbearing age in order to promote early entry into prenatal care and the availability of Medicaid coverage for eligible pregnant women not ver in prenatal care, and assist in further developing a systems approach for at-risk women and infants for appropriate health and social services referrals, for the period 10/01/12 to 09/30/13, in the not-to-exceed amount of \$160,000, payable pursuant to an approved budget.

The CHRF was chosen as the agency for this contract as it coordinates the New York State-designated regional perinatal network for the lower Hudson Valley. The selection of this agency is also consistent with the directive from the New York State Department of Health (NYSDOH) to involve this regional perinatal network in developing an organized system of perinatal health and home visiting services for Westchester County with this NYSDOH grant - funded Healthy Mom-Healthy Baby Program.

The overall goal of the contract is to address the continued unmet need for coordinated prenatal, postpartum medical care and parenting support/outreach for Medicaid eligible women of childbearing age based upon prenatal care screenings and birth certificate reviews. Entry into prenatal care is positively correlated to improved birth outcomes. The CHRF will assist WCDH in further developing and refining a coordinated, comprehensive systems approach to improving the maternal and infant outcomes of Medicaid eligible pregnant clients.

This will be accomplished by assisting the WCDH in developing standardized criteria for linking women's unmet medical and social needs with referrals for health and social services and working collaboratively with Medicaid prenatal care providers and Medicaid managed care programs to increase the percentage of Medicaid eligible women who can receive medical care. The CHRF will also develop and implement a pilot with Peer Place Network (PPN) software to streamline a coordinated system for arranging and tracking referrals and follow up among home visit agencies and other communitybased agencies involved in assessing prenatal care risks and needs.

The WCDH will track and monitor CHRF for compliance with contract deliverables through the analysis of quarterly and annual activity reports submitted by CHRF which will be incorporated into the WCDH reports submitted to the NYSDOH.

This contract is exempt from the Westchester County Procurement Policy under section 3(a) viii as contracts for medical and/or health related services.
