On September 12, 2012, three (3) bids were received and opened for Contract No. 12-534 for Roofing Replacement, 25 Moore Avenue, Mount Kisco, New York.

The bids were reviewed by the Department and it was determined that Sony NY Management & Construction Corp. **(MBE)** submitted the low bid in the amount of \$249,000.00.

The low bidder has been investigated and it has been found that Sony NY Management & Construction Corp. **(MBE)**:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to maintain the weather tightness of the Mount Kisco District Office Building.

This contract is in the public's best interest because it will extend the life of the existing structure.

This project will provide an environmental benefit by meeting current New York State Energy Codes resulting in a reduction in energy consumption. Additionally, installation of a reflective top coating meets current LEED standards which reduces the heat island effect, a contributing factor to global warming, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 12-534 be awarded to Sony NY Management & Construction Corp. **(MBE)** in the amount of \$249,000.00.
