SUBJECT: Seeking authority : 1) to amend a Resolution originally approved on December 9, 2010 and subsequently amended on December 22, 2011, March 8, 2012, June 7, 2012 and July 5, 2012 which authorized the County to enter into agreements with One Hundred Eighty-Eight (188) agencies to provide day care services for households eligible for child day care subsidies through the New York State Child Care Block Grant, Title XX for the term commencing January 1, 2011 and continuing indefinitely until terminated by either party in order to authorize the County to enter into agreements with six additional agencies; and 2) to amend the agreements with **156 agencies** listed on Schedule "A" attached hereto and made a part hereof to add language requiring that requests for payment be electronically submitted as soon as possible and no later than 60 days after the end of each service month

By resolution adopted on December 9, 2010, and subsequently amended on December 22, 2011, March 8, 2012, June 7, 2012 and on July 5, 2012 (the "Resolution"), your Honorable Board authorized the County to enter into agreements with one hundred eighty-one (188) licensed child care centers, licensed family group programs and registered school-age programs for the provision of child care services to Title XX eligible families as well as low income eligible households for the term commencing January 1, 2011, or commencing upon execution, and continuing indefinitely until terminated by either party, payable pursuant to an approved budget and at rates not to exceed authorized maximum rates set by the Office of Children and Family Services. Authority is now requested to further amend the Resolution to authorize the County to enter into agreements with the six additional agencies listed below for the term

commencing upon execution and extending indefinitely until terminated by either party upon 30 days prior written notice to the other party:

All other terms and conditions of the Resolution and the Agreements shall remain in full force and effect.
