SUBJECT: Request for Authority to Solicit Bids by Public Advertisement for Six (6) Moving Services Contracts of Voting Machines, Supply Bags and Privacy Booths between the County Warehouse and Various Polling Place Locations for all 2013 Primary, Special and General Elections covering Zones 1 through 6 (BOE 13-07, BOE 13-08, BOE 13-09, BOE 13-10, BOE 13-11 and BOE 13-12, respectively).

Attached for your consideration is a Resolution which, if approved by your Honorable Board, would authorize the Department of Public Works and Transportation to solicit bids by public advertisement for six (6) moving services contracts of voting machines, supply bags and privacy booths for zones 1 through 6, respectively, between the County Warehouse and various polling place locations in the County of Westchester (the "County") for all 2013 Primary, Special and General Elections (BOE 13-07, BOE 13-08, BOE 13-09, BOE 13-10, BOE 13-11 and BOE 13-12, respectively). These six (6) contracts will commence on or about February 15, 2013 and terminate on December 31, 2013.

Since the final number of the voting districts that are holding primaries have not yet been determined, the County will receive a pro-rata credit based upon the number of polling places in each zone that are ultimately used in the Primary and Special Elections.

The public purpose, as well as the goal and objective of this contract, is to allow the Board of Elections to carry out its statutory duties in connection with all upcoming 2013 Primary, Special and General Elections and to ensure that all eligible County residents have the opportunity to exercise their right to vote.

The six (6) contracts shall be for the following geographic zones:

2013 Primary, Special and General Election Moving Services of Voting Machines, Supply Bags and Privacy Booths, Zone 3 - Greenburgh, Harrison, Mount Pleasant, North Castle and White Plains

2013 Primary, Special and General Election Moving Services of Voting Machines, Supply Bags and Privacy Booths, Zone 4 - Mamaroneck, New Rochelle, Rye Town and Rye City

Pursuant to applicable law, the County is required to store, transport and secure voting machine equipment in connection with all Primary, Special and General Elections. Due to the large numbers of voting machines, supply bags and privacy booths that must be transported to and from polling place locations, this service is best handled through an outside vendor as the County does not have sufficient staff to carry out this work. By having such a contract in place, the County will be able to carry out its statutory duties in connection with the upcoming 2013 Elections.

The performance of the successful bidder under this contract will be monitored by the staff of the Department of Public Works and Transportation to ensure compliance with contract terms.

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
