On October 3, 2012, four (4) bids were received and opened for Contract No. 12-222 for Roofing Repairs and Services at DPW Maintained Facilities, Westchester County, New York.

The bids were reviewed by the Department and it was determined that Reluzco Contracting Corp. submitted the low bid in the amount of \$106,620.00.

The low bidder has been investigated and it has been found that Reluzco Contracting Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

Funds for this project are available in the:

- Capital Budget
 Non-Recurring Budget
 Operating Budget

The objective of this contract is to maintain the weather tightness of the County's buildings.

This contract is in the public's best interest because it will promote the health and safety of the general public by allowing County Facilities to remain operational along with protecting County property by maintaining the weather tightness of County buildings, thus addressing the County Executive's priority area: Fiscal Responsibility (FR). There are no energy or environmental components associated with this project.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

This contract is for a term of three (3) years with one two (2) year renewal at the discretion of the County.

It is my recommendation that Contract No. 12-222 be awarded to Reluzco Contracting Corp. in the amount of \$106,620.00, subject to appropriations.

RESOLUTION

CONTRACT NO. 12-222

Upon communication from the Commissioner of Public Works and Transportation, be it

RESOLVED, that Contract No. 12-222 for Roofing Repairs and Services at DPW Maintained Facilities, Westchester County, New York be and is hereby awarded to the low bidder, Reluzco Contracting Corp., 13 Locust Street, Valhalla, New York 10595, in the amount of \$106,620.00; and be it further

RESOLVED, that as set forth in the Contract No. 12-222 bid specifications, this contract is for a term of three (3) years with one two (2) year renewal at the discretion of the County; and be it further

RESOLVED, that this contract is subject to County appropriations; and be it further

RESOLVED, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
