SUBJECT: Authority to: (1) enter into an Operating Assistance Agreement with P.T.L.A. Enterprise, Inc. ("P.T.L.A.") for the provision of Public Transportation Services as part of the Bee-Line Bus System, whereby the payment made to P.T.L.A. by the County of Westchester (the "County") will not exceed \$2,370,614.00 for the period January 1, 2013 through December 31, 2013; (2) enter into a Lease Agreement with P.T.L.A., whereby for \$1.00 per year, P.T.L.A. will lease from the County buses, vehicles and equipment required for the operation of Public Transportation Services for the period January 1, 2013 through December 31, 2013; and (3) allow the County to make advance payments to P.T.L.A. (Agreement No. DOTOP02-13)

It is anticipated that the 2013 Department of Public Works and Transportation's Operating Budget will include funding for operating assistance to privately owned bus companies that provide transit service as part of the Bee-Line Bus System. This funding, subject to appropriation, will be for the period January 1, 2013 through December 31, 2013.

It is estimated that the total bus operating assistance required to fund bus service provided by P.T.L.A. Enterprise, Inc. ("P.T.L.A.") for 2013 will be an amount not to exceed \$2,370,614.00. Authority is therefore requested to enter into an Operating Assistance Agreement with P.T.L.A. to provide Public Transportation Services for the period January 1, 2013 through December 31, 2013 for an amount not to exceed \$2,370,614.00, payable pursuant to an approved budget. Authority is also requested to allow the County of Westchester (the "County") to make advance payments to P.T.L.A. This Resolution may require modification once the 2013 Operating Budget for Westchester County is adopted by the Board of Legislators.

In order for the Operating Assistance Agreement to be fully exercised, authority is requested to enter into a Lease Agreement with P.T.L.A. for the period January 1, 2013 through December 31, 2013, for a yearly fee of one dollar (\$1.00) for the lease of buses, vehicles and equipment related to the operation of the Public Transportation Services.

This agreement serves a public purpose as it provides public transportation services to the residents of Westchester County. This agreement will be monitored by the Department of Public Works and Transportation to ensure compliance with the agreement terms.

In view of the importance of this Public Transportation Service, I recommend approval of the attached Resolution.

RESOLUTION

Upon a communication from the Commissioner of Public Works and Transportation, be it hereby:

RESOLVED, that the County of Westchester (the "County") is hereby authorized to enter into an agreement (Agreement No. DOTOP02-13) with P.T.L.A. Enterprise, Inc. ("P.T.L.A.") for the provision of Public Transportation Services as part of the Bee-Line Bus System for the period January 1, 2013 through December 31, 2013, in an amount not to exceed \$2,370,614.00, payable pursuant to an approved budget and subject to appropriation; and be it further

RESOLVED, that the County is also authorized to enter into a Lease Agreement with P.T.L.A. for an annual fee of one dollar (\$1.00) to lease buses, transit communication equipment, maintenance and supervisory vehicles, and other related equipment required for the operation of the Bee-Line Bus System, for the period January 1, 2013 through December 31, 2013; and be it further

RESOLVED, that the County is hereby allowed to make advance payments to P.T.L.A.; and be it further

RESOLVED, that these Agreements are subject to appropriation; and be it further

RESOLVED, that these Agreements are also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of these Agreements. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate these Agreements or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his duly authorized designee is authorized to execute any and all instruments and take such other actions as may reasonably be necessary to effectuate the purposes thereof.
