Re: Authority to amend a retainer agreement with the Wicks Group, PLLC for the provision of “of counsel” legal services to the County Attorney in connection with various legal issues relating to the Westchester County Airport, by extending the term of the agreement for an additional year and by increasing the amount not-to-exceed by an additional \$100,000

By resolution approved on November 3, 2011 (the “November 3rd Resolution”), your Honorable Board authorized the County to enter into a retainer agreement with the Wicks Group, PLLC (the “Wicks Group”) for the provision of outside counsel services in connection with various legal issues relating to the Westchester County Airport for a one (1) year term commencing upon execution of the retainer agreement by both parties and approval of same by the Office of the County Attorney (the “Agreement”). The November 3rd Resolution further provided that in consideration for services to be rendered, the Wicks Group would be paid at the blended rate of Three Hundred (\$300.00) Dollars per hour or Two Thousand (\$2,000.00) Dollars per day per attorney (plus normally reimbursable expenses such as travel, long distance telephone calls, copying, etc.), for a total aggregate amount not to exceed One Hundred Thousand (\$100,000.00) Dollars, inclusive of all expenses. The Agreement was fully executed and approved as of November 22, 2011.

Your Honorable Board initially authorized the retention of the Wicks Group after a nationwide competitive proposal process in 2011 to identify a source of counsel in the specialized fields of airport law and administrative practice before the Federal Aviation Administration (“FAA”). The Wicks Group was chosen both on the basis of their outstanding qualifications and their fee structure, which was substantially below those of other firms practicing in the same field.

Although the Agreement expired on November 21, 2012, the County continues to require the services of the firm to provide on-going legal counsel concerning various legal issues affecting the Airport. Accordingly, the authority of your Honorable Board is respectfully requested to amend the Agreement with the Wicks Group in order to 1) extend the term thereof

for one (1) additional year commencing retroactive to November 22, 2012 and continuing through November 21, 2013; and 2) increasing the not-to-exceed amount authorized thereunder by an additional One Hundred Thousand (\$100,000.00) Dollars, from an amount not-to-exceed One Hundred Thousand (\$100,000.00) Dollars to an amount not-to-exceed Two Hundred Thousand (\$200,000.00) Dollars.

Except as specifically amended hereby, all remaining terms and conditions of the Agreement shall remain in full force and effect.

By Act No. 2013-7 approved on January 28, 2013, the Westchester County Board of Legislators authorized the County to continue to retain, at County expense, the Wicks Group for an additional one (1) year term commencing retroactive to November 22, 2012 and continuing through November 21, 2013 for an additional amount not-to-exceed \$100,000, payable at the same rates as provided during the initial term.

It should be noted that this contract will be funded through the Airport Special Revenue Fund, and no tax levy funds will be involved.

The goals and objectives of this Agreement will be to ensure that the Airport is in compliance with all FAA regulations. The goals and objectives are in the best interest of the County by insuring the safety of the traveling public. The goals and objectives will be tracked and monitored through monthly reports to be supplied by the firm detailing the services rendered.

Accordingly, your favorable action on the annexed Resolution is most respectfully urged and recommended.

RESOLUTION

Upon a communication from the County Attorney, be it hereby:

RESOLVED, that the County of Westchester is authorized to amend a retainer agreement with the Wicks Group, PLLC for the provision of outside counsel services in connection with various legal issues relating to the Westchester County Airport (the "Agreement") by 1) extending the term of the Agreement for one (1) additional year commencing retroactive to November 22, 2012 and continuing through November 21, 2013; and 2) increasing the not-to-exceed amount authorized thereunder by an additional One Hundred Thousand (\$100,000.00) Dollars, from an amount not-to-exceed One Hundred Thousand (\$100,000.00) Dollars, to an amount not-to-exceed Two Hundred Thousand (\$200,000.00) Dollars; and it is further

RESOLVED, that except as specifically amended hereby, all remaining terms and conditions of the Agreement shall remain in full force and effect; and it is further

RESOLVED, that all funding for this retainer agreement will come from the Airport Special Revenue Fund and no County tax levy funds would be appropriated for this purpose; and it is further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to take such action and execute such documents as may be necessary and proper to effect the purposes hereof.
