Re: Resolution authorizing the County of Westchester to exercise its fourth option with On Assignment Staffing Services, Inc., for the provision of temporary lab personnel on an as-needed basis, at a total cost to the County not-to-exceed Two Hundred Eleven Thousand Five Hundred Five Dollars (\$211,505.00), for this one (1) year extension period, commencing January 1, 2013 and terminating on December 31, 2013.

On January 29, 2009 your Honorable Board approved a resolution (the "2009 Resolution") that authorized the County of Westchester (the "County") to enter into an agreement (the "Agreement") with On Assignment Staffing Services, Inc., for the provision of temporary lab personnel on an as-needed basis, at a total annual cost to the County not-to-exceed Two Hundred Thirty-Eight Thousand (\$238,000.00) Dollars for the one (1) year period commencing January 1, 2009 and terminating on December 31, 2009, with options exercisable in the County's sole discretion to renew the agreement for four (4) additional one (1) year periods, at renewal rates subject to negotiation at the time of the renewals.

On January 21, 2010, your Honorable Board approved a resolution authorizing the County to exercise its first option to renew the Agreement for the renewal term January 1, 2010 through December 31, 2010, at a total cost to the County not-to-exceed Two Hundred Nineteen Thousand Two Hundred Eighty Dollars and Sixty-Two Cents (\$219,280.62). On February 3, 2011, your Honorable Board approved a resolution authorizing the County to exercise its second option to renew the Agreement for the renewal term January 1, 2011 through December 31, 2011, at a total cost to the County not-to-exceed Two Hundred Five Thousand Eight Hundred Sixty-Two Dollars and Fifty Cents (\$205,862.50). On February 9, 2012, your Honorable Board approved a resolution authorizing the County to exercise its third option to renew the Agreement

for the renewal term of January 1, 2012 through December 31, 2012, at a total cost to the County not-to-exceed One Hundred Seventy-Five Thousand Nine Hundred Sixty-Four Dollars and Ten Cents (\$175,964.10). The aforesaid options were duly exercised by the County

The County, acting by and through the Department of Labs and Research (the "Department"), is now desirous of exercising its fourth option to renew the Agreement for an additional one-(1) year term at a total amount not-to-exceed Two Hundred Eleven Thousand Five Hundred Five Dollars (\$211,505.00), for this one (1) year option period. Accordingly, authority is hereby requested from your Honorable Board for the County to exercise its option to renew the agreement for an additional one (1) year term.

The goal and objective of the Agreement is to provide the residents of Westchester County with the most qualified temporary lab personnel to conduct forensic and public health analysis. The value and importance are in the best interest of the County in terms of ensuring continued public health and safety. The goals and objectives will be tracked and monitored by each division which maintains attendance records and the proficiency of the temporary personnel. These personnel are paid on an hourly basis for which the County is billed weekly. Division heads approve weekly timesheets which are forwarded to the vendor and returned with the weekly billing.

On Assignment Staffing Services, Inc. has always been very responsive to the Department's needs and has historically provided the Department with excellent service at a good price. Accordingly, I recommend that your Honorable Board approve the attached resolution authorizing the County to exercise its fourth option to renew the Agreement with On Assignment Staffing Services, Inc.
