Contractor: Bilotta Construction Corp.
Amount: \$2,196,461.80

On May 22, 2013, ten (10) bids were received and opened for Contract No. 13-509 for Road Resurfacing and Drainage Improvements, Ward Pound Ridge Reservation, Towns of Lewisboro and Pound Ridge, New York.

The bids were reviewed by the Department and it was determined that Bilotta Construction Corp. submitted the low bid in the amount of \$2,196,461.80.

The low bidder has been investigated and it has been found that Bilotta Construction Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving, thus addressing the County Executive's priority area: Safety and Security (SS).

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that roadways within Ward Pound Ridge Reservation meet current codes and standards as well as reducing the County's annual maintenance costs.

The project will provide an environmental benefit by eliminating flooding conditions due to insufficient drainage systems.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 13-509 be awarded to Bilotta Construction Corp. in the amount of \$2,196,461.80.
