By Resolution approved on November 3, 2011 your Honorable Board awarded Contract No. 11-541 for Resurfacing and Related Improvements, Wappanocca Avenue and Ridge Street (C.R. # 54 & 54C), from Highland Avenue to High Street, a Distance of 0.62 Miles, City of Rye, New York to ELQ Industries, Inc. in the amount of \$593,999.00, for the period November 17, 2011 through February 14, 2013. The Contract was subsequently executed.

Contract completion was delayed due to scheduling of utility service connections (water, sewer, electric and gas) for new houses being built within the project limits. Therefore, the County now seeks authority from your Honorable Board to amend the November 3, 2011 Resolution budget box end date from February 14, 2013 to December 31, 2013.

All other terms and conditions of the November 3, 2011 Resolution and the Contract shall remain in full force and effect and unchanged.
