The approval of five (5) Subcontractors has been requested by Bilotta Construction Corp., 296 Purchase Street, Rye, New York 10580 for the above referenced contract.

Bilotta Construction Corp. ("Bilotta") canvassed three (3) MWOB firms for Clean Drainage and Structure Systems Work. Of those three (3) firms, two (2) firms expressed interest but failed to submit a proposal within the allotted time frame, and one (1) firm responded as not interested.

Bilotta canvassed three (3) MWOB firms for Landscaping Work. Of those three (3) firms, one (1) firm did not respond to Bilotta's inquiry, one (1) firm's quoted price exceeded the budgeted amount for the type of work being requested, and one (1) firm expressed interest but failed to submit a proposal within the allotted time frame.

Bilotta canvassed two (2) MWOB firms for Striping and Epoxy Paint Work. Of those two (2) firms, one (1) firm responded as not interested, and one (1) firm does not have the relevant experience with the type or quantity of work being requested.

The listed Subcontractors have been investigated, and the Department recommends approval.
