Re: Authority to enter into an Agreement with Chartis (formally known as the American International Group Inc. "AIG") through the brokerage firm of Marsh USA, Inc. of New York, N.Y. to purchase Helicopter Hull and Liability Insurance at a cost not to exceed \$108,202.00 for the policy period November 4, 2013 through November 4, 2014

On November 1, 2012, your Honorable Board approved the purchase of Helicopter Hull and Liability Insurance from Chartis (formally known as the American International Group Inc.), through the brokerage firm of Marsh USA, Inc. of New York, NY for two Bell 407 helicopters, operated by the Department of Public Safety ("DPS") and one Hughes OH-6, ("ground coverage" only). The term for this agreement was November 4, 2012 through November 4, 2013.

Two (2) insurance companies were approached by Marsh USA on behalf of the County, and were asked to provide quotations for insuring the helicopters in the upcoming policy year. After a thorough review of the responses, it was determined that the proposal submitted by Chartis again best served the County's interests, and was the lowest quotation provided. In addition, Marsh was successful in negotiating policy improvements as per the following: A) Search and Rescue and Emergency Expenses (Runway Foaming) have been increased from \$500,000 per occurrence to \$1,000,000 per occurrence and B) Medical Expenses have been increased from \$50,000 per passenger to \$75,000 per passenger

Authority is now requested for the County of Westchester to enter into an agreement with Chartis through the brokerage firm of Marsh USA, Inc. of New York, N.Y. to purchase Helicopter Hull and Liability Insurance for the policy period November 4, 2013 through November 4, 2014. The insurance package provides: a) \$50,000,000.00 "All Risk" "First Dollar" Liability coverage b) Hull Physical Damage Coverage subject to a \$1,000.00 deductible (rotors not in motion) and 1% Hull value deductible (rotors in motion) for the 2 Bell 407 helicopters and "ground coverage" only for the OH-6.

The combined premium for the term November 4, 2013 through November 4, 2014 remains in an amount not to exceed \$108,202.00.

The goals and objectives of this agreement are to provide insurance coverage for the Helicopters. The goals and objectives are in the best interest of the County in terms of fiscal responsibility because the insurance coverage will protect County assets in the event of an accident, thus insuring public service continuity and reducing risk for all parties. Risk Management will track and monitor any reports of incidents and/or accidents occurring over the policy period and prepare a summary report at the end of the policy period identifying number of occurrences and corrective actions taken (as necessary) to prevent recurrence.

The proposed Agreement will serve a public purpose by protecting County assets in the event of an accident, thus ensuring public service continuity and reducing risk for all parties.

Accordingly, your favorable action on the annexed Resolution is recommended.

RESOLUTION

Upon a communication from the County Attorney, be it hereby

RESOLVED, that the County of Westchester (the "County") is hereby authorized to enter into an agreement with Chartis (formally known as the American International Group Inc. "AIG") through the brokerage firm of Marsh USA, Inc. of New York, New York to purchase Helicopter Hull and Liability Insurance; and be it further

RESOLVED, that under the terms of the agreement, the policy shall provide: a) \$50,000,000.00 "All Risk" "First Dollar" Liability coverage b) Hull Physical Damage Coverage subject to a \$1,000.00 deductible (rotors not in motion) and c) 1% hull value deductible (rotors in motion) for each of the two County Bell 407 helicopters and "ground coverage" only for the Hughes OH-6; and be it further

RESOLVED, that the premium cost of the insurance package at policy inception shall not exceed \$108,202.00 for the Policy Period November 4, 2013 through November 4, 2014; and be it further

RESOLVED, that this Agreement is subject to County appropriations; and be it further

RESOLVED, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount, then the Insurance companies shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized to execute all instruments and take all actions reasonably necessary to implement this Resolution.
