**RE:** Resolution authorizing the County of Westchester to enter into a grant agreement with the State of New York to accept funding to improve access to polling places in the amount of \$36,891.00 for the term January 1, 2012 through September 30, 2016.

Authority is requested for the County of Westchester, acting by and through its Board of Elections (the "BOE"), to enter into a grant agreement with the State of New York (NYS Contract No. T003311) to accept New York State Voting Access for Individuals with Disabilities funding in the amount of \$36,891.00 payable on a reimbursement basis, for the term commencing on January 1, 2012 and terminating on September 30, 2016.

The State of New York, acting by and through the New York State Board of Elections has allocated to Westchester County these funds which are to be utilized to establish, expand and improve access to and participation by individuals with a full range of disabilities in the election process.

The public purpose of the proposed agreement is to facilitate the purchase of necessary equipment and to make physical improvements to ensure that voters with disabilities have access to all poll sites across Westchester County. Utilizing grant funding will alleviate the need for the use of County tax dollars for this purpose.

We certify that the BOE: a) has copies of, or access to, all applicable laws, rules, regulations, grant applications and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the “Grant Terms”), b) has reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.

In order to take advantage of these grant funds and to enter into the grant agreement your approval of the annexed proposed resolution is requested.
