RE: **Resolution authorizing the County of Westchester to enter into a grant agreement with the State of New York for the County's Department of Laboratories and Research's Division of Toxicology to participate in the Highway Safety Program for a term commencing October 1, 2013 and expiring September 30, 2014, in an amount not to exceed \$45,000**

The attached resolution, if approved by your Honorable Board, would authorize the County of Westchester (the "County") to enter into an agreement (the "Agreement") with the State of New York, pursuant to which the County's Department of Laboratories and Research's (the "Department") Division of Toxicology will participate in the Highway Safety Program for a term commencing October 1, 2013 and expiring September 30, 2014, in an amount not to exceed Forty Five Thousand (\$45,000) Dollars.

The public purpose of this Agreement is to promote the public safety and security of the residents of Westchester through the Toxicology lab's ability to provide timely DWI (Driving While Intoxicated) and DWAI (Driving While Ability Impaired) results, thereby expediting criminal case processing.

The objective of this resolution is to accept state funding to provide the Westchester County Law Enforcement community with timely and quality scientific DWI and DWAI results from the evidence submitted to the Division of Toxicology. Timely analyses are extremely important for prosecution and provide the citizens of Westchester County a higher degree of public safety. The Department will monitor and report the progress of this Agreement in quarterly progress reports provided to the granting authority.

RESOLVED, that the County of Westchester is authorized to enter into an agreement with the State of New York, pursuant to which the County's Department of Laboratories and Research's Division of Toxicology will participate in the Highway Safety Program for a term commencing October 1, 2013 and expiring September 30, 2014, in an amount not to exceed Forty Five Thousand (\$45,000) Dollars; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary and appropriate to effectuate the purposes hereof.
