WHEREAS, there was only one bid for the project, the scope of work will be adjusted in order to solicit more potential bidders; and

WHEREAS, it is requested that all bids received for Contract No. WCC-13-936 be rejected and that Contract No. WCC-13-936 be re-advertised as Contract No. WCC-13-936-Rev for Painting of Academic Arts Building Stacks, Westchester Community College Valhalla, New York

NOW, THEREFORE, BE IT

RESOLVED, that it is in the best interest of the County that all bids for Contract No. WCC-13-936, Painting of Academic Arts Building Stacks, Westchester Community College, Valhalla, New York be and are hereby rejected and that Contract No. WCC-13-936 be re-advertised as Contract No. WCC-13-936-Rev for Painting of Academic Arts Building Stacks, Westchester Community College, Valhalla, New York; and be it further

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance bond in an amount equal to 100% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the US Treasury's listings of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Local Law No. 27-1997 of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
