On November 20, 2013, seven (7) bids were received and opened for Contract No. 13-223 for Infrastructure Improvements, Yonkers Joint Wastewater Treatment Plant and Weaver Street Pump Station, Yonkers and Mamaroneck, New York.

The bids were reviewed by the Department and it was determined that Spectraserv Inc. submitted the low bid in the amount of \$219,527.00.

The low bidder has been investigated and it has been found that Spectraserv Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to allow the Department of Environmental Facilities to maintain its treatment plant systems and to ensure continuous and reliable processing of wastewater.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring continued uninterrupted operation of the plant's wastewater treatment systems. This project will enable the Department of Environmental Facilities to carry out its basic mission to provide wastewater treatment and maintain satisfactory water quality, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 13-223 be awarded to Spectraserv Inc. in the amount of \$219,527.00.

RESOLUTION

CONTRACT NO. 13-223

Upon communication from the Commissioner of Public Works and Transportation, be it

RESOLVED, that Contract No. 13-223 for Infrastructure Improvements, Yonkers Joint Wastewater Treatment Plant and Weaver Street Pump Station, Yonkers and Mamaroneck, New York be and is hereby awarded to the low bidder, Spectraserv Inc., 75 Jacobus Avenue, So. Kearny, New Jersey 07032, in the amount of \$219,527.00; and be it further

RESOLVED, that this contract is subject to County appropriations; and be it further

RESOLVED, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
