Carey, pursuant to which Mr. Carey will provide consulting services to the County of Westchester Public Utility Service Agency and the County of Westchester

Authority is hereby requested from your Honorable Board to exempt from the Westchester County Procurement Policy and Procedures an agreement between the County of Westchester (the "County"), acting by and through the County of Westchester Public Utility Service Agency ("COWPUSA"), and Timothy S. Carey, pursuant to which Mr. Carey will provide consulting services to the County and COWPUSA, including, among other things, serving as legislative liaison at the County, State, and Federal levels; serving as Executive Director of COWPUSA; and preparing and presenting statements and position papers before Federal, State, and other agencies, authorities, and commissions, for the period January 1, 2014 through December 31, 2014.

Mr. Carey has extensive, invaluable experience with energy issues. Mr. Carey has previously served as a board member for the New York State Energy Research and Development Authority ("NYSERDA"), including serving as acting chairman of the board in 2001. From November 2000 to September 2005, Mr. Carey also served as one of five members of the Board of the New York Power Authority ("NYPA"). Subsequently, from September 2005 to January 2006, Mr. Carey served as NYPA's Chief Operating Officer, and from February 2006 to July 2007, Mr. Carey served as NYPA's President and Chief Executive Officer. Mr. Carey has also served as the Executive Director of COWPUSA since November 2010.

Based upon the foregoing, it is proposed that the best interests of the County would be

served by exempting this agreement from the Westchester County Procurement Policy and Procedures, pursuant to Section 3(a)(xxi) thereof. Therefore, a resolution to exempt this procurement is hereby submitted for your consideration.
