On November 13, 2013, eight (\$) bids were received and opened for Contract No. 11-504 for Rehabilitation of Warburton Avenue Bridge (BIN 3348270) over Cropsey Lane, Village of Hastings-on-Hudson, New York.

The bids were reviewed by the Department and it was determined that Arben Group LLC submitted the low bid in the amount of \$5,989,648.00.

The low bidder has been investigated and it has been found that Arben Group LLC:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to repair substandard structural elements of the Warburton Avenue Bridge, thus addressing the County Executive's priority area: Safety and Security (SS).

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Warburton Avenue Bridge meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 11-504 be awarded to Arben Group LLC in the amount of \$5,989,648.00.
