Re: **Authority for the County of Westchester, acting by and through its Department of Public Works and Transportation (the “Department”), to execute an agreement consenting to the assignment of Agreement No. 13-933 with GHD Consulting Engineers, LLC to GHD Consulting Services Inc.**

Pursuant to a Resolution approved on November 7, 2013, the County of Westchester (“County”) entered into Agreement No. 13-933 (the “Agreement”) with GHD Consulting Engineers, LLC (“Consultant”), One Remington Park Drive, Cazenovia, New York 13035, commencing on November 22, 2013, wherein the Consultant was to provide construction administration services associated with the Pump Station Rehabilitation Program, Croton Point Park Landfill, Croton-on-Hudson, New York.

The Department was notified by way of a letter dated January 14, 2014 that “GHD Consulting Engineers, LLC has reorganized in New York State to operate as GHD Consulting Services Inc.” In this regard, it was requested in the aforesaid letter that the County consent to the assignment of Agreement No. 13-933 between GHD Consulting Engineers, LLC and the County, to GHD Consulting Services Inc. Therefore, GHD Consulting Services Inc. would assume all of the rights and obligations under Agreement No. 13-933.

The attached Resolution, if approved by your Honorable Board, would authorize the County to execute an agreement consenting to the assignment of Agreement No. 13-933 from GHD Consulting Engineers, LLC to GHD Consulting Services Inc. effective as of the date of execution of the assignment.

The objective of this assignment is in the County’s best interest because it will provide for uninterrupted consulting services pursuant to Agreement No. 13-933 for the Department project contained therein.

The Department shall continue to track and monitor the progress of the Agreement.

Accordingly, your favorable action on the annexed Resolution is most respectfully urged and recommended.
