The 2014 Capital Account contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to remove existing invasive plant species through methods of herbicide applications along with clearing and grubbing. The project will include installation of boulder vanes, stone revetments and boulder toe stabilization on both sides of the Bronx River along with replacement of asphalt pathways.

The objective of this contract is to stabilize the streambank on the Bronx River using a combination of structural and bioengineering techniques.

This contract is in the public's best interest because it will provide the environmental benefit of reducing flooding and erosion, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
