**SUBJECT:** Resolution authorizing the County of Westchester to enter into an agreement with Manhattanville College to use the East Room, 2<sup>nd</sup> floor of Benziger Hall on October 23, 2014 to host the County's Annual Police Interactive Training Conference

The County of Westchester, acting by and through its Office for Women, is requesting authority to enter into an agreement with Manhattanville College (the "College") pursuant to which the College will grant to the County, and the County will accept, a permit to use the College's premises and facilities located in the East Room, 2<sup>nd</sup> floor of Benziger Hall on Thursday, October 23, 2014, between 8:00am and 4:00pm in order to host the County's Annual Police Interactive Training Conference (the "Agreement").

Under the proposed Agreement, the College is waiving the permit fee and requesting only that the County sign a general release whereby the County will agree to use the premises and facilities at its own risk, and further, be responsible for *any* damage caused by the County or its representatives or those acting under the County's direction, to the premises or facilities of the College.

The proposed Agreement will serve a public purpose by providing a forum to educate local police and probation officers on domestic violence and sexual assault issues to benefit the community.

This agreement is exempt from the requirements of the Westchester County Procurement Policy pursuant to Section 3(b) thereof.

Accordingly, I most respectfully recommend the adoption of the annexed Resolution.

# RESOLUTION

Upon a communication from the Director of the Office for Women, be it hereby

**RESOLVED**, that the County of Westchester ("County"), acting by and through its Office for Women, is hereby authorized to enter into an agreement with Manhattanville College (the "College") pursuant to which the College will grant to the County, and the County will accept, a permit to use the College's premises and facilities located in the East Room, 2<sup>nd</sup> floor of Benziger Hall on Thursday, October 23, 2014, between 8:00am and 4:00pm in order to host the County's Annual Police Interactive Training Conference (the "Agreement"); and be it further

**RESOLVED**, that the College is waiving the permit fee and requesting only that the County sign a general release whereby the County will agree to use the premises and facilities at its own risk, and further, be responsible for *any* damage caused by the County or its representatives or those acting under the County's direction, to the premises or facilities of the College; and be it further

**RESOLVED**, that the County Executive or his authorized designee is authorized and empowered to execute and deliver all instruments and take all actions necessary or appropriate to effectuate the purposes hereof.
