SUBJECT: Resolution to amend the grant agreement with the New York State Division of Homeland Security and Emergency Services in compliance with the FY11 Urban Area Security Initiative in order to extend the term of the agreement from August 31, 2014 through February 28, 2015

On May 24, 2012, your Honorable Board approved a resolution which authorized the County of Westchester ("County"), acting by and through its Department of Emergency Services ("Department"), to enter into a grant agreement with the New York State Division of Homeland Security and Emergency Services ("State") to accept \$1,123,645 in funding to assist the County in its efforts to address equipment, training and planning needs to enhance Westchester's capability to prevent, deter, respond to, and recover from threats or acts of terrorism and mitigate man-made and natural hazards in compliance with the FY11 Urban Area Security Initiative for the period September 1, 2011 through August 31, 2014. The State has notified the Department that it is extending the term of the agreement through February 28, 2015.

Authorization is now requested to amend the grant agreement with the State in order to extend the term of the agreement from August 31, 2014 through February 28, 2015. All other terms and conditions of the grant agreement shall remain the same and in full force and effect.

This grant agreement serves the public's best interest as it will enhance emergency preparedness and thereby preserve the health, safety and general welfare of County residents. The goals and objectives of this program are to address vulnerabilities and develop capabilities to meet target capabilities as outlined in the Federal Guidelines. This includes providing assistance to and support for surveillance, detection, interdiction, response, mitigation, operations and recovery from man-made events associated terrorist attacks.

I certify that my department, a) has copies of, or access to, all applicable laws, rules, regulations, grant applications, and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the "Grant Terms), b) has reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.
