On October 15, 2014, three (3) bids were received and opened for Contract No. 14-532 for Milling and Resurfacing, Various County Roadways, City of Peekskill and Towns of New Castle, Bedford and Pound Ridge, New York.

The bids were reviewed by the Department and it was determined that Montesano Brothers, Inc. submitted the low bid in the amount of \$1,275,710.00, and has proposed the utilization of the following subcontractors: Verde Electric Maintenance Corp. (Traffic Signal Work), 89 Edison Avenue, Mount Vernon, New York 10550; and Safety Marking Inc. (Pavement Markings), 255 Hancock Avenue, Bridgeport, Connecticut 06605.

The low bidder has been investigated and it has been found that Montesano Brothers, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving, thus addressing the County Executive's priority area: Safety and Security (SS).

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that various County roadways in the City of Peekskill and Towns of New Castle, Bedford and Pound Ridge meet current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 14-532 be awarded to Montesano Brothers, Inc. in the amount of \$1,275,710.00.
