RE: Resolution authorizing the County of Westchester to enter into an agreement with the New York State Division of Criminal Justice Services to receive grand funds under Project "GIVE" in an amount not to exceed \$68,750 for the period July 1, 2014 through June 30, 2015 pursuant to an approved budget

Authority is sought for the County of Westchester to enter into an agreement with the New York State Division of Criminal Justice Services to receive grant funds in an amount not to exceed \$68,750 under Project GIVE (Gun Involved Violence Elimination "GIVE" Initiative). The goal of this Initiative is the elimination of shootings and homicides through the integrated use of evidence based strategies that include the four core elements of People, Places, Alignment and Engagement. The objective is to implement a joint agency initiative to directly combat shootings and homicides in Yonkers and Mount Vernon with support and assistance from other law enforcement agencies. The Department of Public Safety will assign personnel to deploy targeted operations as outlined in the GIVE strategy through joint agency initiatives. The funds received from the State will enable the Department of Public Safety to assign personnel to support Project GIVE strategies in Yonkers and Mount Vernon.

This contract impacts the County's critical priority areas in the following manner:

- Fiscal Responsibility – The County will receive reimbursement for activities performed by the Department pursuant to Project GIVE.

This contract has the public purpose of promoting public safety through the implementation of operations under Project GIVE.

This matter is exempt from the procedures of the Procurement Policy under Section 3(a)iii of the Procurement Policy.
