Authority of your Honorable Board is requested to enter into an Agreement in connection with the Rehabilitation of Bloomer Road, C.R. #39, Town of North Salem, New York. The consultant shall provide design services associated with this project. Design services shall include the preparation of construction contract documents (drawings and specifications), construction cost estimates, any required addenda, and a bid analysis including an evaluation of the bids to determine compliance with bidding requirements and whether the bidders are responsible so that the County may recommend award of the construction contracts. In addition, the consultant shall provide design services during construction consisting of shop drawing and submittal review, attendance at project meetings, periodic site visits and preparation of as-built drawings.

The objective of this project will be to rehabilitate Bloomer Road, C.R. #39, in North Salem, New York. This work is necessary due to extensive deterioration of the roadway. The rehabilitation work shall include, but not be limited to, the following items: milling existing asphalt concrete pavement; filling and sealing joints and cracks; adjusting castings, catch basins, and utility structures; repairing catch basins; replacing all existing frames and grates; removal and replacement of deteriorated pavement along edges of roadway; replacing/upgrading traffic islands at Route 121; addressing drainage issues, roadside safety, and existing driveways; resurfacing roadway with asphalt; topsoil and seeding as needed; and installing new pavement markings. This agreement will benefit the public as it will enhance the functionality of the roadway ensuring its safe use by the public, thus addressing the County Executive's priority area of Safety and Security.

Since the estimated fee for professional services was greater than \$100,000, in accordance with the Rules of the Professional Prequalification and Selection Boards, on October 24, 2013, a meeting of the Professional Prequalification Board was held to discuss the scope of work and request a list of qualified firms to provide the necessary services. The list was reviewed by the Professional Selection Board on November 26, 2013 whereby Ammann & Whitney Consulting Engineers, PC; Dolph Rotfeld Engineering, PC; Gibbons, Esposito & Boyce Engineers, PC; Greenman-Pedersen, Inc.; Lockwood, Kessler & Bartlett, Inc.; and PS&S Engineering, Inc. were selected to possibly perform said services. On August 25, 2014, a request for proposal (RFP) was sent to the qualified firms and subsequently proposals were received on October 7, 2014.

After reviewing the proposals, and based on the evaluation criteria set forth in the request for proposal, including technical merit and net cost, the Professional Selection Board at its meeting held November 12, 2014, selected Greenman-Pedersen, Inc., 325 West Main Street, Babylon, New York 11702, as the number one firm to perform engineering services in connection with the Rehabilitation of Bloomer Road, C.R. #39, Town of North Salem, New York, for a total fee of \$129,992.00, pursuant to an approved budget, which represents the best possible contract for the County.

In addition, Greenman-Pedersen, Inc., has requested the utilization of the following subconsultant: Gayron de Bruin Land Surveying & Engineering, PC (Surveying and Mapping Services), 11 Union Avenue, Bethpage, New York 11714.

The proposed has been reviewed and is judged to be responsive to the task at hand.

The Department of Public Works and Transportation will track scheduling and accomplishments by the consultant and perform on-site inspections to ensure the successful completion of this project.

This matter has been reviewed by the Deputy County Executive and the Commissioner of the Department of Planning, and they are in concurrence.

I recommend adoption of the attached proposed Resolution.

RESOLVED, that for services rendered in accordance with the consultant's proposal, a total compensation of \$129,992.00, shall be provided, pursuant to an approved budget; and be it further

RESOLVED, that the use of the following subconsultant also be approved: Gayron de Bruin Land Surveying & Engineering, PC (Surveying and Mapping Services), 11 Union Avenue, Bethpage, New York 11714; and be it further

RESOLVED, that the Agreement shall commence upon the consultant's receipt of written notice from the Commissioner of Public Works and Transportation or his designee and that the completion date shall be December 31, 2018; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
