The 2015 Operating Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to perform testing, inspections and repair services on the IQ/PowerNet System located at Valhalla Campus. This contract is for a term of three (3) years with one two (2) year renewal at the discretion of the County.

The objective of this contract is to provide for the continued operation of the IQ/PowerNet system.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring the continued reliability of the IQ/PowerNet System along with reducing the County's annual maintenance costs, thus addressing the County Executive's priority area: Fiscal Responsibility (FR).

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.
