**SUBJECT:** Authority to enter into an agreement with Westchester Hispanic Coalition, Inc. to assist low-income immigrants in applying for administrative relief, for a term commencing January 1, 2015 and continuing through December 31, 2015, for an amount not-to-exceed \$20,600

The attached Resolution, if approved by your Honorable Board, would authorize the County of Westchester, acting by and through its Office for Women, (the "County") to enter into an agreement (the "Agreement") with Westchester Hispanic Coalition, Inc. ("WHC") pursuant to which WHC will assist low-income immigrants in applying for administrative relief, for a term commencing January 1, 2015 and continuing through December 31, 2015, for an amount not-to-exceed \$20,600, payable quarterly pursuant to an approved budget.

The proposed Agreement will serve a public purpose by increasing the stability and self-sufficiency of Latino immigrant men and women in Westchester.

The goal and objective of the proposed Agreement is for WHC to assist 40 low-income immigrants in applying for administrative relief including, but not limited to, Special Immigrant Juveniles Status, Deferred Action for Childhood Arrivals, Temporary Protective Status, work authorization renewals, and legal permanent resident status.

The goal and objective of the proposed Agreement will be tracked and monitored by the Office for Women.

Authority to exempt these services from the requirements of the Westchester County Procurement Policy pursuant to Section 3(a)(xxi) thereof has been requested from your Honorable Board in accordance with a separate resolution of the same date heretofore.

Attached for your consideration is a proposed Resolution.

# RESOLUTION

Upon a communication from the Westchester County Executive, the Chairman of the Westchester County Board of Legislators, and the Director of the Office for Women be it hereby

**RESOLVED**, that the County of Westchester, acting by and through its Office for Women, (the "County") is hereby authorized to enter into an agreement (the "Agreement") with Westchester Hispanic Coalition, Inc. ("WHC") pursuant to which WHC will assist low-income immigrants in applying for administrative relief, for a term commencing January 1, 2015 and continuing through December 31, 2015, for an amount not-to-exceed \$20,600, payable quarterly pursuant to an approved budget; and be it further

**RESOLVED**, that this Agreement is subject to County appropriations; and be it further

**RESOLVED**, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

**RESOLVED**, that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute any and all documents and take any actions necessary to effectuate the purposes hereof.
