RE: AUTHORITY TO ENTER INTO A LICENSE AGREEMENT WITH  
TRAHANAS AMUSEMENTS, INC., 4 MANHATTAN AVENUE, RYE,  
NEW YORK 10580 FOR THE OPERATION OF A CONCESSION RIDE  
KNOWN AS THE "FLYING WITCH" AT PLAYLAND PARK FOR  
THE 2015 OPERATING SEASON FOR A TERM COMMENCING  
MAY 9, 2015 AND TERMINATING SEPTEMBER 30, 2015

Authority is requested of this Board for the County of Westchester to enter into a license agreement with Trahanas Amusements, Inc. for the operation of a concession ride known as the "Flying Witch" at Playland Park, Rye, New York for the 2015 operating season for a term commencing May 9, 2015 and terminating September 30, 2015.

As consideration for this license privilege, Trahanas Amusements, Inc. will pay the County of Westchester a license fee of 40% of gross receipts during the operating season.

The goal and objective of this agreement is to increase County revenue while providing a safe attraction for Playland patrons. This agreement promotes fiscal responsibility as the County will benefit from the additional revenue.

The objective of this agreement will be monitored using inspection and ridership reports.

This agreement is exempt from the County's procurement policy pursuant to Section 3 (b).

A Resolution is attached for your favorable consideration.

# RESOLUTION

Upon a communication from the Commissioner of the Department of Parks, Recreation and Conservation, be it hereby

**RESOLVED**, that the County of Westchester is authorized to enter into a license agreement with Trahanas Amusements, Inc., 4 Manhattan Avenue, Rye, New York 10580 for the operation of a concession ride known as the "Flying Witch" at Playland Park, Rye, New York 10580 for the 2015 operating season for a term commencing May 9, 2015 and terminating September 30, 2015; and be it further

**RESOLVED**, that for this license privilege, Trahanas Amusements, Inc., will pay the County of Westchester a license fee of 40% of gross receipts during the operating season; and be it further

**RESOLVED**, that the County Executive or his authorized designee is hereby empowered to execute any and all instruments and take such other actions as may reasonably be necessary to effectuate the purposes thereof.
