SUBJECT: **Authorization to extend a contract with F&B Car Service, LLC for the provision of taxi services within the City of Yonkers for customers of the County's Para Transit program for the period July 1, 2015 through June 30, 2016, in an amount not to exceed \$150,000.00. (Contract No. 14-206 / DOTOP05-14)**

On March 26, 2014, bids were received and opened for Contract No. 14-206 / DOTOP05-14 for Para Transit Bee-Line Cab Services, City of Yonkers, New York, for customers of the County's Para Transit Program for a term of one (1) year with the County's option to extend the contract for one (1) additional one (1) year term. Pursuant to a resolution approved on June 12, 2014, F&B Car Service, LLC was awarded the contract as the low bidder. Based on the satisfactory performance of the contractor under the contract, the Department of Public Works and Transportation and the Office for the Disabled would like to exercise its option to extend the contract for a one (1) year period commencing July 1, 2015. In addition, due to the demand for this service, it is requested that the amount be increased from \$100,000.00 to \$150,000.00.

The extension of this contract is in the public's best interest as it will continue to provide a cost effective alternative to traditional Para Transit for ambulatory citizens, thus addressing the County Executive's priority area: Fiscal Responsibility (FR).

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

A proposed resolution is attached for your consideration.

RESOLUTION

CONTRACT NO. 14-206 / DOTOP05-14

Upon communication from the Commissioner of Public Works and Transportation and the Director of the Office for the Disabled, be it

RESOLVED, that the County of Westchester is hereby authorized to extend contract No. 14-206 / DOTOP05-14 on the same terms and conditions with F&B Car Service, LLC, 192 Nepperhan Avenue, Yonkers, New York 10701, for the provision of taxi services within the City of Yonkers to customers of the County's Para Transit program in an amount not to exceed \$150,000.00 for a term of one (1) year commencing July 1, 2015; and be it further

RESOLVED, that all other terms and conditions of Contract No. 14-206 / DOTOP05-14 with F&B Car Service, LLC shall remain the same; and be it further

RESOLVED, that this agreement is subject to County appropriations; and be it further

RESOLVED, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
