RE: Request for authority for the County of Westchester to amend its agreement with the New York State Office for the Aging to accept a grant in the sum of \$1,286,813 to provide funding for the Community Services for the Elderly Program, for the program period April 1, 2015 through March 31, 2016, by increasing the total authorized not to exceed amount thereunder by \$129,468.

By resolution approved on March 05, 2015 (the "March 05th Resolution"), your Honorable Board authorized the County of Westchester (the "County"), acting by and through its Department of Senior Programs and Services (the "Department"), to enter into an agreement with the New York State Office for the Aging ("NYSOFA") to accept a grant in the sum of \$1,286,813 to provide State funding for the Community Services for the Elderly Program (the "CSE Program") for the program period April 1, 2015 through March 31, 2016 (the "NYSOFA Agreement"). The NYSOFA Agreement was subsequently executed.

The Department was recently notified by NYSOFA that it intends to increase funding for the CSE Program by an additional \$129,468, thereby increasing the total amount authorized under the NYSOFA Agreement from \$1,286,813 to \$1,416,281. Accordingly, authority is now sought from your Honorable Board to amend the NYSOFA Agreement for the limited purpose of increasing the not-to-exceed amount authorized thereunder by \$129,468, from \$1,286,813 to \$1,416,281. It should be noted that the additional funding will be used to enter into inter-municipal agreements to provide transportation services to seniors under separate resolution.

Except as specifically amended hereby, all other terms and conditions of the NYSOFA Agreement shall remain in full force and effect.

Accordingly, I most respectfully recommend adoption of the attached proposed resolution.

RESOLUTION

RESOLVED, that the County Executive or his duly authorized designee be, and hereby is, authorized to take such actions and execute such documents as may be necessary and appropriate to effectuate the purposes hereof.
