On August 5, 2015, two (2) bids were received and opened for the provision of Paratransit Bee-Line Taxi Services in the City of Yonkers utilizing existing regulated taxi companies within the City of Yonkers.

The bids were reviewed by the Department and it was determined that All County Transportation Service, Inc. ("ACT") submitted the low bid. ACT met all of the bid specifications and their experience has been investigated and found to be satisfactory. In an effort to reduce costs to the County, the Department negotiated with ACT, and ACT agreed to reduce their pricing per fare by \$43,283.00 from their original submittal.

Authority is requested for the County of Westchester to enter into a contract with ACT for the provision of ParaTransit Bee-Line Cab Services in the City of Yonkers for an amount not to exceed \$200,000.00 for a term of one (1) year with the County's option to extend the contract for one additional one year period on the same terms and conditions.

# RESOLUTION

## CONTRACT NO. DOTOP 04-15

Upon communication from the Commissioner of Public Works and Transportation and the Director of the Office for the Disabled, be it

**RESOLVED**, that the contract for Taxi Pilot Program Services, City of Yonkers, New York be and is hereby awarded to All County Transportation Service, Inc., 2 John Walsh Boulevard, Peekskill, New York 10566 in an amount not to exceed \$200,000.00 for a term of one (1) year commencing on October 1, 2015 with the County's option to extend the contract for one additional one year period on the same terms and conditions; and be it further

**RESOLVED**, that this contract is subject to County appropriations; and be it further

**RESOLVED**, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

**RESOLVED**, that the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
