The 2016 Operating Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required for periodic cleaning and lead abatement of the County's indoor Firing Range. Work also includes all required containment and disposal of hazardous materials. This contract shall be for a term of three (3) years with one two (2) year renewal at the sole discretion of the County.

The objective of this contract is to maintain the Firing Range for continuous and uninterrupted operation.

This contract is in the public's best interest because it will provide weekly and quarterly maintenance and service that is critical for the continued operation of this facility, thereby enhancing the health and safety of County and Local Government employees that utilize the Firing Range.

This project will provide an environmental benefit by removing hazardous materials which will eliminate the possibility of future contamination.

The performance of the successful bidder under this contract will be monitored by the staff of the Department of Public Safety (the "Department") to ensure compliance with contract terms. In addition, as expenditures are made pursuant to this authorization, detailed records will be kept in

the County's on-line financial system. These records will be easily accessible by Finance, Budget and Department staff and will be reviewed regularly to ensure that funds are used appropriately.
