This contract shall be for a term of three (3) years with one two (2) year renewal at the sole discretion of the County.

This contract is in the public's best interest because it will provide weekly and quarterly maintenance and service that is critical for the continued operation of this facility, thereby enhancing the health and safety of County and Local Government employees that utilize the Firing Range.
