SUBJECT: Resolution to amend the grant agreement with the New York State Division of Homeland Security and Emergency Services in compliance with the FY12 Urban Area Security Initiative in order to extend the term of the agreement from August 31, 2015 through November 30, 2015

On December 6, 2012, your Honorable Board approved a resolution which authorized the County of Westchester ("County"), acting by and through its Department of Emergency Services ("Department"), to enter into a grant agreement with the New York State Division of Homeland Security and Emergency Services ("State") to accept funds in an amount not-to-exceed \$1,123,645.00 for the period September 1, 2012 through August 31, 2014. The goals and objectives of the Urban Area Security Initiative are to enhance Westchester County's capability to prevent terrorist attacks and mitigate against man-made and natural hazards; protect the public, critical infrastructure and key resources, and prepare to respond to and recover from both man-made and natural disasters. The State notified the Department that it was extending the term of the agreement and on September 24, 2014, your Honorable Board approved a resolution to extend the term of the agreement from August 31, 2014 through August 31, 2015.

The State has recently notified the Department that it is extending the term of the agreement through November 30, 2015. Authorization is now requested to amend the grant agreement with the State in order to extend the term of the agreement from August 31, 2015 through November 30, 2015. All other terms and conditions of the grant agreement, as amended, shall remain the same and in full force and effect.

This grant agreement serves the public's best interest as it will enhance emergency preparedness and thereby preserve the health, safety and general welfare of County residents. The goals and objectives of this program are to address vulnerabilities and develop capabilities to meet target capabilities as outlined in the Federal Guidelines. This includes providing assistance to and support for surveillance, detection, interdiction, response, mitigation, operations and recovery from man-made events associated terrorist attacks.

I certify that my department, a) has copies of, or access to, all applicable laws, rules, regulations, grant applications, and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the "Grant Terms), b) has

reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.

In view of the importance of this program, I recommend approval of the attached resolution.
