SUBJECT: **Authorization to enter into a grant agreement with the New York State Division of Homeland Security and Emergency Services to accept \$362,117 in grant funding under the FY15 Local Emergency Management Performance Grant Program for the period October 1, 2014 through September 30, 2016 with the County contributing a 50% matching share of \$362,117.**

Authorization is requested for the County of Westchester ("County"), acting by and through its Department of Emergency Services ("Department"), to enter into a grant agreement with the New York State Division of Homeland Security and Emergency Services ("DHSSES") to accept Federal funds through the Federal Emergency Management Agency under the FY15 Local Emergency Management Performance Grant ("LEMPG") Program. Proceeds from the grant will be used by the Department to pay the salaries of County Emergency Management Personnel directly related to Emergency Management, Recovery, and Hazard Mitigation planning and community response team oversight, lease expense of the Westchester County EOC and OEM offices and a tabletop exercise for County and local officials. The Emergency Management Personnel develop and maintain emergency plans; facilitate and attend state and County sponsored training; and design and participate in drills and exercises. During response, the Emergency Management Personnel assist in saving lives by staffing the County EOC for incidents such as Hurricane Sandy; facilitating information sharing and situational awareness across local, County, and non-governmental partners; managing county logistics assistance; and supporting mass care and shelter operations. During recovery, the Emergency Management Personnel work with local municipalities, County government, New York State and FEMA to assess damage and facilitate restoration efforts and support whole community efforts to assist citizens' in their short term needs such as food, water, clothing, and temporary housing.

The grant is for the period from October 1, 2014 through September 30, 2016, in a total amount not to exceed \$362,117. Under the terms of the grant, the County is required to contribute a 50% matching share of \$362,117 in the form of cash and in-kind services (personnel and fringe expenses for services related to emergency management, including mitigation, preparedness, response and recovery, lease expense of the Westchester County EOC and OEM offices and a tabletop exercise for County and local officials).

This grant agreement serves the public's best interest as it will enhance emergency preparedness and thereby preserve the health, safety and general welfare of County residents. The goals and objectives of this program are to sustain the County's emergency preparedness program by providing emergency plans, training, exercises and compliance with the National Incident Management System/Incident Command System. In addition, this program plays an important role in the implementation of Presidential Policy Directive 8 (PPD-8) by supporting the development and sustainment of core capabilities. Core capabilities are essential for the execution of each of the five mission areas outlined in the National Preparedness Goal (NPG). The development and sustainment of these core capabilities are not exclusive to any single level of government or organization, but rather require the combined effort of the whole community. The FY 2015 LEMPG Program supports all core capabilities in the prevention, protection, mitigation, response, and recovery mission areas based on allowable costs. The Department will be able to monitor the effectiveness of this effort through a series of performance measures required by DHSES.

RESOLUTION

Upon a communication from the Commissioner of Emergency Services, be it hereby

RESOLVED, that the County of Westchester, acting by and through its Department of Emergency Services, is authorized to enter into a grant agreement with the New York State Division of Homeland Security and Emergency Services (“DHSES”) to accept Federal funds through the Federal Emergency Management Agency under the FY15 Local Emergency Management Performance Grant Program to assist the County in its efforts to sustain its emergency preparedness program for the period from October 1, 2014 through September 30, 2016, for a total amount not to exceed \$362,117, with the County contributing a 50% matching share of \$362,117 in the form of cash and in-kind services (personnel and fringe expenses for services related to emergency management, including mitigation, preparedness, response and recovery, lease expense of the Westchester County EOC and OEM offices and a tabletop exercise for County and local officials); and be it further

RESOLVED, that the County Executive or his authorized designee is authorized and empowered to execute and deliver all instruments and take all actions necessary or appropriate to effectuate the purposes hereof.
