Re: Authority to enter into affiliation agreements with (i) Montefiore New Rochelle Hospital; (ii) VA Hudson Valley Health Care System; (iii) The Hope Center, St. John's Riverside Hospital; for clinical education and instruction of students in the Human Services/Pre-Social Work Program.

Included in the programs offered by Westchester Community College (the "College") is a Human Services/Pre-Social Work program. The College offers supervised clinical education and instruction for matriculated Westchester Community College students who are pursuing a degree or certificate in this program in conjunction with various organizations. Attached is a resolution that would authorize the College to enter into agreements commencing on January 1, 2016 and terminating on December 31, 2020 for assistance in providing this instruction with the following organizations:

1. Montefiore New Rochelle Hospital;
2. VA Hudson Valley Health Care System;
3. The Hope Center, St. John's Riverside Hospital; and

There will be no cost to the College, but the parties will cross indemnify each other for their respective negligence.

I believe that it is in the best interest of the College to provide clinical education and instruction programs; and I therefore, recommend that you act favorably on the annexed proposed resolution.

3. The Hope Center, St. John's Riverside Hospital; and
